

Informed Consent for Minors - Tattoo

The undersigned declares to have been informed that:

- a) Tattooing is an invasive procedure that involves the permanent application of ink and dyes under the skin using an electric device (tattoo machine) and one or more needles attached to it;
- b) To remove its effects, surgical interventions are necessary, which do not always guarantee the restoration of previous conditions;
- c) There are risks associated with this practice, such as the possible transmission of certain infectious diseases, including the human immunodeficiency virus (HIV - AIDS) and viral hepatitis B and C;
- d) As a consequence of the described treatments, inflammations, infections, allergies, temporary swelling, or possible temporary or permanent scars may occur;
- e) Tattoos cannot be performed on skin with ongoing inflammatory processes;
- f) It is not recommended to get tattoos during pregnancy or breastfeeding;
- g) Blood donation is not possible for at least six months.

The undersigned declares:

- To commit to following the guidelines related to the healing period and to be aware that not adhering to them may compromise the success and healing of the tattoo itself;
- To be aware that tattooing is a manual and artisanal artistic practice and that consequently, no guarantee is provided regarding the result of the proposed tattoo;
- To be aware that the more immobile the person remains during the execution of the tattoo, the more precise it will be;
- To be aware that the rendering of colours on the skin varies according to complexion;
- The minor has previously undergone a test for tolerance to the colours used for the tattoo;
- The minor does not suffer from any conditions or allergies that would prevent undergoing tattooing;
- To have personally verified the cleanliness of the premises, the sterilisation of the equipment, and the use of disposable needles.
- To be aware that no guarantee or insurance is provided regarding the results of the procedure and to assume all risks associated with it;

I declare that I have no mental or pathological impediments that prevent me from consenting to have the minor tattooed or that contraindicate my ability to have the minor tattooed, who has consciously and freely chosen the design to be imprinted;
